Breaking News! Victory— Board of Supervisors Agrees to Allow Current Employees and/or Retirees on Independent Citizen's Pension Committee

On Tuesday, April 25, the Board of Supervisors relented and agreed to allow current and/or former County employees to be on the Independent Citizens Pension Committee. Thanks to the people who spoke on Tuesday, as well as emails, meetings, and advocacy by ESC Local 20 and SEIU 1021 members. The Board's previous position which barred current and/or former County employees' participation, would have meant that some of the most important stakeholders could not have had a seat on the committee.

Short Term Disability Insurance Survey

We have an opportunity to change our Short Term Disability ("STD") insurance coverage. Currently, we have STD insurance through Sun Life Ins. Co. The cost is \$1.11 per \$100 MCP, with a maximum bi-weekly deduction of \$32.72 and a maximum weekly benefit of \$1,000.00. There are 4 options open to us, all of which would include an open enrollment period.

- 1. Stay with Sun Life on a 1-year extension of the current rate and benefits:
- 2. Switch to Mutual of Omaha, for the same benefits at a slightly reduced rate (\$1.08 per \$100 MCP), with a 2 year rate guarantee;
- 3. Keep Sun Life at the current rate (\$1.11 per \$100 MCP) with an increase to the maximum weekly benefit to match current California SDI of \$1,173;
- 4. Switch to Mutual of Omaha at the current rate (\$1.11 per \$100), with an increase to the maximum weekly benefit to match current California SDI of \$1,173.
