Dear Mr. Sperry:

The Company has recently begun a pilot of a new work process, "Express Connect," which will handle estimating of certain disconnect/reconnect work. The Company intends to establish two pilot groups, one located in Stockton (Boeing Way) to handle work in Stockton and Yosemite Divisions, and one at the Fresno RMC to cover Fresno and Kern Divisions.

Recognizing that many Hiring Hall Electric Estimators are currently performing this work in several locations in the affected Divisions, the Company proposes under Section 26.1 to relocate the Hiring Hall Estimators listed below. These employees have been informed about the pilot program and have expressed their willingness to work in the headquarters shown.

The Company also notes that it will fill an Associate Distribution Engineer (ADE) position for Express Connect in Stockton by temporarily assigning a Senior Estimator Passed Test at that location to ADE, and an ADE position in Fresno RMC with an ADE already located at that location. Further, the Company intends to add three additional Hiring Hall Estimators in Stockton for the pilot. The Company will first offer the Bakersfield Local Headquarters Hiring Hall Estimators the opportunity to relocate to the Fresno RMC and the Union will authorize any such relocation under Section 26.1 as noted above. Additional Hiring Hall Estimators at Fresno RMC may be assigned to Express Connect work for Bakersfield, and the Company intends to transfer their work to Hiring Hall Estimators in Bakersfield who are currently doing this work in Bakersfield.

The Union and Company will meet to review and evaluate the progress and performance of this pilot program.
